



# The Independent Review Office Officially Established

### **Tuesday 2nd March 2021**

The Independent Review Office (IRO) has been officially established, replacing the Workers Compensation Independent Review Office from 1 March 2021.

#### WHAT HAS CHANGED - CTP COMPLAINTS

Since 2012, the Workers Compensation Independent Review Office has helped injured workers reach fair solutions with their insurers. New laws have expanded our functions, and we can now help people injured in motor accidents (CTP complaints) and people injured at work and solve complaints about their insurers.

The IRO website (<u>www.iro.nsw.gov.au</u>) explains the changes to our office and provides information on how to make a CTP complaint.

These Guidelines have been under development since the passage of the *Personal Injury Commission Act 2020* in August 2020. In large part, they reflect the Funding Policy, Grant Amount Guide and Approval Requirements for Approved Lawyers operative prior to 1 March 2021.

## Currently approved lawyers and barristers do not need to reapply

Currently approved IRO (formerly WIRO) Lawyers and Barristers do not need to apply again for approval under the new Guidelines.

The new Practice Standards for IRO Approved Lawyers and the new Agreements (to be an IRO Approved Lawyer or Approved Barrister) apply to all current Approved Lawyers and Barristers.

### **New Grant Application Forms**

While we encourage you to immediately adopt the new form, IRO will accept WIRO Grant Application Forms until further notice.

## Guidelines apply to grants approved or resolutions achieved on or after 1/3/21

The ILARS Funding Guidelines apply to applications for a grant of funding (including for an extension of a grant of funding) made or approved on or after 1st March 2021, and grants of funding made or approved before the commencement of the Guidelines where the final outcome of the matter is achieved on or after 1st March 2021.

The previous Funding Policy and Grant Amount Guide, which have been superseded by the ILARS Funding Guidelines, continue to apply to grants of funding made before 1st March 2021, where a final outcome of the subject of the grant is achieved before 1st March 2021.
